THE COIN

THE STARS

3 stars on the front of the coin represent the 3 jurisdictions that form the legal foundation of the group. The 5 stars at the back stand for the 5 founders who gave birth to the idea and transformed the vision to reality. 3 and 5 are Fibonacci numbers adding up to 8, the universal number of infinity.

THE SWISS CROSS

The cross on the front center of the coin resembles the Swiss coat of arms. Its baroque frame pays tribute to the fame and glory of the 'golden century' in Europe.

THE LION AND THE MOUNTAIN

The mountain (Matterhorn) and the lion (Merlion) on the back center symbolise Switzerland and Singapore. In many cultures mountains have a spiritual significance and stand for strength and durability. The lion is the king of animals. In ancient cultures it symbolised resurrection, courage, justice and invincibility.

THE GLOBE AND THE FLOWER OF LIFE

The globe symbolises the main aim of DUCATUS - to provide a safe digital currency for the whole world. At its side stands the Flower of Life, the symbol of harmony, growth, peace and perfection. It is strongly tied to the Fibonacci series of numbers and the golden ratio, the perfect design of Life itself.

The Principles at the outer circle on both side of the coin are written in Latin, the language of the Roman Empire widely used by merchants and intellectuals, where the Ducatus coin has its origin. CHARITY ACCOUNT

Funds in the Charity Account are used to provide support and relief to carefully selected projects around the world. A small percentage of the commissions will be distributed to this account and when a project has been chosen, the partners will be asked if they would like to support by donating the accumulated amount. SPECIAL FEATURES

BUSINESS VOLUME (BV) ACCUMULATION

All BV earned from day one accumulates indefinitely and automatically. One Euro of mining credit sales is valued as 0.8 BV!

QUALIFICATIONS, BONUS AND CAREER LEVELS

Qualifications and Career levels once received will remain in place forever. Achieved bonuses will be calculated and credited on the same day they are earned.

LIFESTYLE BONUS

Each partner reaching the career level of BRONZE is automatically eligible to qualify for the lifestyle bonus program. Please check the LIFESTYLE PROGRAM TABLE for further details.

SUPERBONUS

Precious Miners from level Silver onwards are qualified for a share in the company's super bonus which is paid out every 6 months and based on the worldwide sales revenue of Swissmine during that period. I% of worldwide sales revenue will be distributed amongst the qualifying partners based on a preset formula.

RULER SHARE

8% of the annual net profit from Swissmine operations will be made available to partners reaching the ruler ranks. Pay-out of this annual bonus will be released 14 days after the annual audit for the company has been approved by the Board of Directors.

DIRECT BONUS

Receive **8+5**% **direct bonus** on the Business Volume (BV) from Mining Credits bought by your directly sponsored partners.

For packages of 5,000 Euro or higher, you will earn an additional 5%, making the total direct bonus amount 18% - the highest in the industry!




TEAM BONUS

To qualify for the Team Bonus you need to purchase mining credits for a minimum of €50 and sponsor at least 2 First-Line Partners, each purchasing €50 credits or more.

After that the BV accumulates indefinitely, automatically leading to higher bonus levels. Team Bonuses are NOT paid on personal revenues.

Qualifications must only be fulfilled once.






MATCHING BONUS

The Matching Bonus is calculated on the direct and team bonus of your down-line partners. It is paid until the 13th level.

To qualify, you must purchase a minimum of €250 mining credits. Additionally three directly enrolled First-Line Partners with a minimum of €250 credits purchased are required.

This qualification only needs to be fulfilled once.





FAST START BONUS

Receive a ONE-TIME €400 Bonus with a cumulative turnover of at least 5,000 BV within 30 days of registration.

To qualify, a minimum of 30% BV must be brought in by the weaker legs of the network!

With a cumulative turnover of at least 10,000 BV the ONE-TIME Bonus paid will rise to € 1,300!

SUPER BONUS

LIFESTYLE PROGRAM + 1% of the Worldwide Revenue

The lifestyle program bonus commences when a partner attains the rank of BRONZE and is paid monthly if ongoing qualifications are met! For details please refer to the LIFESTYLE PROGRAM TABLE.

Partners reaching the precious rank of SILVER or higher will be additionally rewarded between I and 21 shares of 1% of the worldwide revenue. This Super Bonus is paid out twice a year (June 15th and December 15th) based on the revenue achieved in the six months prior to the respective pay-out date. Qualification is based upon performance up to the last day of the previous month.

When achieving the position of DC Senator, DC Centurion and DC Emporer, the company offers an additional annual pay-out reserved through the 'RULER' share in the company for as long as the partner stays actively involved and continues to support his or her network.

Bronze members and above qualify for our special Lifestyle Bonus. The qualification period is monthly and runs from the first until the last day of the month. In order to qualify for the Lifestyle Bonus members must reach the respective targets for both 'OWN BV' and 'TEAM BV'. The assessment of 'OWN BV' will also include any package purchases which are made using funds from that member's trading account.

If in a certain month a member misses the qualification for his current Lifestyle Bonus level but reaches the qualification for a lower level then the bonus amount for the lower level will be paid for that month.

For each country in the Ducatus Global Network, management will select a specific type of reward which will apply to all Lifestyle Bonus rewards in that country e.g. car, holiday, cash or other type of reward depending on each country's specific situation.
